PROCEEDINGS :

- 1. Mr. S.K. Bhattacharya welcomed all the members present.
- 2. On the tragic demise of Sh. G.P. Chopra, Chairman of DAV Managing Committee, silence of one minute was observed.
- 3. Minutes of the last meeting held on 29th August, 2011, were read and confirmed.
- 4. Mr. S.K. Bhattacharya explained the CIC declaration in the matter of DPS Rohini that RTI was made applicable to private unaided schools as they were allotted land by DDA. He invited the opinion of the house on this matter :
 - a. Mr. Sewa Singh explained in detail Section 2(h) of RTI Act and stressed that an organization should be receiving substantial finance from the govt. to come under the Act.
 - b. Mr. S.L. Jain opined that the comparison of DPS with Sanskriti School was an error as Sanskriti School is funded by the govt.
 - c. Mrs. Sangeeta Bhatia said that Action Committee should support DPS.
 - d. Mr. Y.P. Purang said that land allotted by DDA is not at concessional rate but at institutional rate. The institutional rates were decided by the govt. to help the residents with schooling facilities.
 - e. Mr. M.S. Rawat said that Mrs. Annapurna Dixit, Information Commissioner gave a totally different kind of order in a similar case. He proposed that Action Committee should become party in the legal case.
 - f. Mr. Shah drew the attention towards the gravity of the matter and said that all the schools would be doomed if DPS fails.
 - g. Mr. T.R. Gupta said that we must join DPS with full force.

- h. Mr. Bhattacharya summarized the views of all and said that legal opinion of Senior Advocates like Mr. Harish Salve or Mr. Rajiv Dhawan will be taken and then the line of action will be decided.
- 5. Mr. S.K. Bhattacharya said that every year the Department of Education issues guidelines for Admission to Nursery class thereby diluting the autonomy of Private Unaided Schools. It was proposed that a committee under the Chairmanship of Mr. M.L. Babbar be formed to draft suggestive admission guidelines. The President of each constituent Member Organization would nominate a member on this committee.

It was unanimously agreed and decided that the organization would forward the name of their nominees within next four days. Mr. Babbar was requested to submit the guidelines within 14 days.

- 6. Mr. Bhattacharya informed the august gathering that as per High Court Order dated 12/8/2011, a three member committee under the chairmanship of Justice Anil Dev Singh is constituted. This committee is to look into the accounts of all the schools.
- 7. Mr. Bhattacharya proposed a committee under the Chairmanship of Mr. S. L. Jain to draft the suggestive Accounting Manual. Mr. Jain was requested to take the help of Chartered Accountants. This committee would also suggest guidelines for determining the guantum of fee hike required, if any.
- 8. Mr. R.C. Jain said that the schools which are existing on smaller plots are not being regularized. This is against the spirit of Right to Education Act.
- 9. Mr. S.L. Jain stressed the need of transparency and accountability.
- 10. Mr. S.L. Jain proposed the vote of thanks with special mention to Mrs. Mamta Bhatnagar for being the wonderful host.
