PROCEEDINGS:

- 1. Mr. S.K. Bhattacharya welcomed all the members present.
- 2. Minutes of the Emergent Meeting held on 16th August, 2011, were read and confirmed.
- 3. Everyone present wished happy long life to Mr. Sanjay Bhartiya who was having his birthday on 29th August, 2011.
- 4. Mr. S.K. Bhattacharya appraised the audience about all the court cases in progress.
- 5. In the matter of admission to Pre-School the next date of hearing is 14/10/2011.

- 6. The judgement of High Court of 12/8/2011, regarding the order of Directorate of Education dated 11/2/2009 allowing limited fee hike, was discussed and deliberated upon.
- 7. Mr. Bhattacharya informed that the representatives of Action Committee had met the review committee set up by the Govt. of Delhi to review Delhi Education Act and Rules. The suggestions and recommendations of the Action Committee were submitted to the Review Committee. Special thanks were given to Mr. Sobti and Mr. Purang and other members of the team who drafted the recommendations of Review Committee.
- 8. Mr. Bhattacharya informed that the Department of Education was in the process of standardizing book keeping and accounting of all schools. Anyone interested can take a copy of the format from Mr. Bedi.
- 9. He appraised the gathering about the RTE matter. Solicitor General of India had submitted written arguments on 9/8/2011. Mr. Rajiv Dhawan has written argument on behalf of the Action Committee.
- 10. Mr. Bhattacharya appraised the august gathering about the income and expenditure. He informed that Action Committee has spent about 24 lakhs on legal matters against the collection of Rs. 22 lakhs. In the RTE matter alone the fee paid to the advocates was about Rs. 17 lacs. The total fee made to the Senior advocates in the RTE matter was about 92.5 lakhs.
- 11. H requested all the members to pay the membership charges promptly and regularly.
- 12. Mr. R.C. Jain informed that he also met the Review Committee of DSEAR and he has given the following recommendations:
 - a. The managers should be allowed to draw salary.
 - b. Section 10(b) is to be reviewed so that the school with less income need not pay salary at par with the Govt. schools.
 - c. According to the master plan, the requirement for Primary School plot is 800 m.sq. To help the smaller schools the plot size limit may be brought down.
 - d. In absence of corporal punishment there is increase in the indiscipline among students.
- 13. Mr. S.L. Jain appealed to all schools that we should all modify our conduct and behaviour and be more transparent.
- 14. The meeting came to close with the vote of thanks to the chair.
