PROCEEDINGS :

1. Mr. Bhattacharya welcomed all the members.
2. Minutes of the meeting held on 8th February, 2012, were read and confirmed.
3. The Income and Expenditure Statement for the year 2011 – 2012 was presented.

Income in the year 2011 – 12 was : Rs. 11,64,159/-
 Total Expenditure was : Rs. 17,84,374/-
 There was net loss of : Rs. 6,20,215/-
4. Mr. Bhattacharya informed about the on-going court cases.
 - (a) Against the Supreme Court Judgement in case of RTE a Review Writ Petition has been filed.
 - (b) In the matter of applicability of RTI on Delhi Public School, Rohini, the High Court itself made Action Committee a party, now the Action Committee is fighting to make sure that RTI is not applicable on Pvt. Unaided schools. The next date of hearing is 4th September, 2012.
5. Mr. K.L. Luthra, General Secretary, informed about the activities of the Action Committee.
 - (a) Mr. Ashok Aggarwal filed a PIL, that there should be only one year Pre-Primary and school should not be allowed to have Nursery Class (Pre-School) in the school premises. Action Committee responded and won the case, the court ordered that the schools can have Pre-School and Pre-Primary.
 - (b) Directorate of Education ordered the fee structure should be approved in the General Body Meeting of the parents.

Action Committee challenged the above order and the Court said the schools were not required to get the fee approved in the General Body Meeting of the parents. The Managing Committee is the only competent authority to decide the fee.
