ORDER

Sub: Regarding Admission Procedure for Pre-Primary classes in the recognized schools imparting education in Delhi.

In partial modification of the previous order dated 27.10.2008 on the subject it is brought to the notice of the managing committees of all private recognized schools in Delhi conducting admissions to Pre-Primary class from the academic year 2010-2011 onwards in the NCT of Delhi, that all admissions to such Pre-Primary classes shall be made as per the schedule given below.

1. ADMISSION SCHEDULE: the following admission schedule is prescribed:

<u>Commencement of admission process</u>	:	15.12.2009
Commencement of availability of admission application forms	:	15.12.2009
Last date for receipt of applications	:	15.01.2010
Scrutiny of applications	:	up to 30.01.2010
Publication of 1 st list of selected children (plus 2 nd /waiting list)	:	01.02.2010
Publication of 3 rd list of selected children (if any)	:	28.02.2010
Publication of 4 th list of selected children (if any)	:	15.03.2010
<u>Closure of admissions</u>	:	31.03.2010

A school can deviate the above schedule depending on their specific circumstances, but, no deviation shall be permitted in respect of the dates of the commencement and closure of admission, i.e., **15.12.2009** and **31.3.2010** respectively. **All schools shall have uniform dates for commencement and closure of admission process.**

Any proposed deviation, if any, from the above schedule shall be intimated to the office of the Director of Education, through the Deputy Director of the District on or before **16:00 hours on 15.11.2009**. The intimation shall invariably be accompanied by reasons for the necessity of the deviation. In the absence of any intimation, accompanied by reasons, giving dates and times, a school shall be bound by the schedule laid down in this order.

All the above directions as contained in the order of the Directorate dated 27.10.2008 shall remain the same and shall be compiled with.
