We have heard the Ld. counsel for the parties. The Govt. of NCT of Delhi urges in its application (CM No. 9882/2018) that the previous order dated 21.02.2018 needs to be modified on three main aspects.

The first aspect relates to the direction to maximise the children's admission by ensuring that the older children can also apply in more than one school for different classes. The Govt. of NCT's stated position is that the existing admission procedure is the result of experts' reports and because of Proviso to Section 4 of the Right to Education Act, (which enacts that the child needing education could be admitted at the appropriate level). It is argued that if an older child is afforded the opportunity of admission under the 25% quota (set apart under Section 12) in a lower class, the chances of others, who are eligible and ought to be adjusted in that level, would diminish. It is stated that Government of NCT of Delhi has set up special training centres under Rule 5 which accommodate older children with lower learning content. The applicant Government also



relies upon a Division Bench judgment of this Court which upheld the circular, that had put a cap on the age limit prescribed for the admission. That judgment is part of the record. In the light of these submissions made, the Court is of the opinion that the direction to remove the age limit (in the order dated 21.02.2018) would not be correct. The said direction is therefore, deleted from the order.

The second clarification sought is regarding the number of applications that can be filed on-line. Here, it is submitted that there is in fact no limit with respect to the number of applications that one can file on-line for children residing within 6 kms radius of a school or set of schools. However, in distances exceeding that, a quantitative limit of five schools has been provided. This Court is of the opinion that in view of this fact and having regard to the circumstance that the Right to Education Act entitles choice of admission, having regard to “the neighbourhood principle”, the limitation as to the number of application to be made beyond the 6 k.m. radius distance is not unreasonable. Therefore, the relevant direction, is hereby deleted.

The third clarification relates to the lack of information regarding exact and accurate particulars of the colonies, since several colonies are identically named in Delhi. It was pointed out during the hearing that the on-line portal has overcome the potential confusion by a two way process; the applicant has to firstly choose the assembly constituency, within which his/her residence is located and appropriately feed it on the on-line application form after which, he/she is allowed to choose from amongst schools located within the



limits of that constituency. In view of this explanation and the on-line feature which the Court had occasion to observe during the hearing, the third direction too is deleted.

It is also submitted that having regard to the volume of applications, which the Govt. of NCT has to process, the periodic monitoring, directed by the Court i.e. on a weekly basis, is not practicable and that instead a quarterly review would be undertaken and appropriate upgradation of the information would be made. This too is a reasonable request. The order therefore, shall stand modified to that extent.

It is submitted that in the light of the previous judgment of this Court in *Neeraj Kumar vs. Ventekeshwar Global School* [WP(C) 7945/2016 decided on 31.3.2017], the Govt. of NCT of Delhi cannot proceed with admissions beyond 31<sup>st</sup> December of any given academic year and that any leftover seats would be “carried forward and added to the forthcoming years with respect to the academic session”. Having regard to the order in W.P(C) 7945/2016, directions of 21.02.2018 to the contrary are hereby modified; they need not be complied with.

Having regard to the provisions of The Rights of Persons with Disabilities Act, 2016, in the light of the interpretation given in *Pramod Arora vs. Hon’ble LG & Ors, Delhi*, the Govt. shall ensure that the admission procedure of the persons with disability is kept separately in EWS category.

1. The petitioners argue that the website/portal devised by the Government of NCT has limitations, which pose as access to the right to education. These are by way of limitation with respect to date of birth, the area code made available in the list of colonies, use of PIN as the basis to access information, cut off date for updating information, etc. It is also highlighted that a continuous review mechanism to oversee the admission process should be put in place. Lastly it was argued that the affidavit of 27 November, 2017 (of the NCT) indicates that for seats left over, an online draw of lots was held; however, without calling for applications from candidates.

2. During the course of hearing the court accessed the website. The petitioners' concerns seem justified. The options with respect to date of birth, as well as the number of applications which may be presented in respect of a child, and lack of clarity with respect to the correct particulars of localities/colonies impede applicants of

children's access to admission to schools in the 25% quota set apart under the Right to Education Act (RTE). The website and the system of admission should be so designed as include children left out from schooling to the maximum possible extent. Therefore, the prevailing option of screening out children who are born earlier (i.e. for instance a child born before 2010 is excluded from applying for nursery admission) or placing limitations on the number of applications (given that children of all age groups are left out from schooling, and not merely those in a particular age group) would amount to *per se* discrimination. Likewise, the lack of information with respect to the exact and accurate particulars of a colony (given that there are several colonies in Delhi with the same name) leads to distorted results; children would secure admission at far off places which would entail long hours of travel, and thus, avoidable expense. These forms of discrimination, dictated by the limited choices and perpetrated through technology, cannot stand in the way of such children's rights under Article 21A of the Constitution of India. The Govt. of NCT of Delhi is therefore directed to ensure that the widest choice is given to the applicants to present applications, on line by making appropriate changes.

3. The Govt. of NCT of Delhi shall ensure that there is a continuous monitoring mechanism which oversees the admission process on a dynamic basis; furthermore, whenever vacancies occur in the course of an academic year (in respect of the 25% quota under the RTE Act) immediate intimation of such vacancies should be made

and applications called for, to fill such seats. For this purpose, the website/portal concerned should be updated on a weekly basis and all notices should be likewise uploaded at the time of such revision.

4. Learned counsel for NCT of Delhi submits that a comprehensive affidavit required of by the court in its previous order, would be filed shortly. While doing so, the government shall also endeavor to comply with the above directions and indicate its action taken in this regard, in its affidavit.
