The proceedings in the matter have been conducted through video conferencing.

1. The GNCTD has filed a status report in terms of paragraph 3 of the order dated 03.05.2021.
2. It appears from the table annexed to the status report that there are several schools in respect of which the amount sanctioned has not been disbursed at all or has been disbursed only partially. In the status report, the only explanation given in this regard is as follows:-

“ xxxxx xxxxx xxxxx
Further, the payment of remaining schools is in process as Finance Department, GNCTD imposed restrictions on the expenditure of departments vide O.M. No.F.1/1/2021-222/Fin(B)-1020-1059 dated 17/06/2021 (Annexure R.2) to regulate the flow of cash during the COVID-19 time. Accordingly any expenditure beyond Rs. 1 crore requires relaxations from the Finance Department, GNCTD.

Directorate of Education had already submitted proposal seeking relaxation of Finance Department, GNCTD, conditions imposed in their order dated 17/06/2021.”

3. Mr. Santosh Kumar Tripathi, learned Standing Counsel for the GNCTD submits orally that the disbursement in many cases has not been possible due to non-compliance with the requirement of Section 12 of the Right of Children to Free and Compulsory Education Act, 2009 [“the Act”] and the circulars issued in this regard by the Directorate of



Education [“DOE”]. I do not find any such reason indicated in the status report. The very purpose of passing the order dated 03.05.2021 was to ascertain whether the non-disbursal of the sanctioned amounts is for good reason. The contents of the status report do not support the submission now being made by Mr. Tripathi, even in the most general terms. Mr. Tripathi submits that the collection of data for 1600 schools and the collation of the same in the status report is cumbersome and the DOE has been unable to undertake the task in view of various other responsibilities relating to the COVID-19 pandemic.

4. Be that as it may, the right of the schools to be compensated in accordance with the Act is undisputed. The reasons for delay in reimbursement of the amounts have to be examined. Having regard to these factors, it would be appropriate for the DOE to at least indicate, without necessarily referring to the case of each school separately, as to the broad reasons which have led to this situation. The DOE is directed to file a further status report within four weeks alongwith copies of any circulars upon which it seeks to rely.

5. Mr. Pramod Gupta, learned counsel for the petitioners, submits that as far as the academic year 2020-21 is concerned, the schools have yet not been permitted even to submit their claims, as the GNCTD has not opened the portal for this purpose. The GNCTD will make its submissions with regard to reimbursement for the academic session 2020-2021 also in the status report.

1. The present application has been filed on behalf of the petitioner under Section 151 CPC for interim directions.
2. By way of the present application, it is submitted that of books, writing material and uniforms, etc. are not provided by the school to the General category students. It is submitted that the said things are purchased by the students studying under the General category from the open market. Thus, it is submitted that when the school does not provide the said amenities to the other General category students, the school is not liable to provide the same to the students studying under the Economically Weaker Section (EWS)/Disadvantaged Group (DG)/Children with Special Needs (CWSN) category.
3. It is further submitted that before the Division Bench of this Court, it has been admitted by the Government that the Government



provides reimbursement to the EWS students towards books, uniforms, etc. Thus, it is contended on behalf of the petitioner that once the department itself has been giving cash reimbursement, they cannot put onerous responsibility on the private un-aided schools for providing books, written material and uniform.

4. Issue notice. Notice is accepted by the non-applicants. Let reply be filed within a period of four weeks. Rejoinder thereto, if any, be filed within a period of two weeks thereafter.
